

ARTICLES OF INCORPORATION

TO THE SECRETARY OF STATE, JEFFERSON CITY, MISSOURI:

We, the undersigned,

- (a) Dr. Lee J. Cary, 300 Mumford Drive, Columbia, Missouri 65201;
- (b) E. Frederick List, 2204 Country Lane, Columbia, Missouri 65201;
- (c) Bryan M. Phifer, 801 College Park, Columbia, Missouri 65201

being natural persons of the age of twenty-one years or more and citizens of the United States of America, for the purpose of forming a corporation under "The General Not For Profit Corporation Law" of the State of Missouri, do hereby adopt the following Articles of Incorporation:

1. The name of the corporation is: The Community Development Society **of AMERICA.**

2. The period of duration of the corporation is: perpetual.

3. The name and address of each incorporator is:

- (a) Dr. Lee J. Cary, 300 Mumford Drive, Columbia, Missouri 65201.
- (b) E. Frederick List, 2204 Country Lane, Columbia, Missouri 65201.
- (c) Bryan M. Phifer, 801 College Park, Columbia, Missouri 65201.

4. The address of the corporation's initial Registered Office in the State of Missouri is: 909 University Avenue, Columbia, Missouri 65201; the name of the corporation's initial Registered Agent at said address is Dr. Lee J. Cary, a resident of Missouri.

5. The first Board of Directors shall be three in number, their names and addresses being the same as those listed in paragraph 3 above.


6. The scientific and educational purpose or purposes for which this corporation is exclusively organized and operated within Section 501(3)(c) of the Internal Revenue Code are:


- (a) to advance the community development profession,
- (b) to provide a forum for the exchange of ideas among the members of the corporation,
- (c) to provide media for the publication of professional, scholarly works, and
- (d) to provide an opportunity for the development of common interests among the members of the corporation.



No part of the net earnings of this corporation shall inure to the benefit of any private member of this corporation or individual and this corporation shall never engage in carrying on propaganda or otherwise attempt to influence legislation, nor shall this corporation participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

8. Upon dissolution, the assets of this corporation shall not be distributed in any form or manner to any member of the corporation; but shall be distributed for one or more exempt purposes within Section 501 of the Federal Internal Revenue Code.
