

Articles of Amendment to the Articles of Incorporation

The undersigned corporation, for the purpose of amending its Articles of Incorporation and pursuant to the provisions of the "General Not For Profit Corporation Law" of the State of Missouri, hereby executes the following Articles of Amendment:

1. The name of the corporation is The Community Development Society of America;
2. There are no members having voting rights with respect to amendments;
- 3(c) At a meeting of directors (members having no voting rights with respect to amendments) held on November 20, 1978, same receiving the votes of a majority of the directors then in office, the following amendment was adopted in the manner prescribed by the "General Not For Profit Corporation Law" of the State of Missouri:

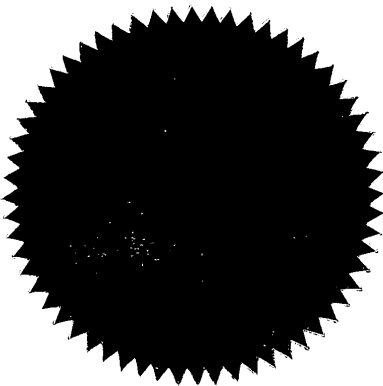
