The Community Development Society board met in beautiful Cincinnati, OH, for our annual mid-year meeting. Cincinnati will host CDS's 2012 annual conference at the Kingsgate Marriott Hotel. During our time at the hotel, we had the opportunity to tour the facility and the surrounding area. The facilities are top notch and serve as a wonderful host and backdrop to our conference. The meeting rooms feature excellent presentation opportunities and the guest rooms are spacious and comfortable.

During our board meeting, a number of items were discussed including the future of the Society and its

membership. You need to be aware that our Society's membership has declined significantly in recent years, and the Board has undertaken an aggressive strategy to recoup many of the lost members.

One of the solutions discussed was to reach out to past non-renewed members and encourage them to once again participate in membership and the annual conference. Another is to insure that all communications to the general membership are also sent to past members. Another is to actively seek partnerships with similarly themed organizations for shared conferences, journal subscriptions, and collaborations. Finally, the CDS Board will explore the potential for offering a wide variety of services to CDS members, including a greater offering of webinars, sponsored workshops in collaboration with sister organizations, and international exchange opportunities. Rest assured that the Board is not going to stand by and watch the Society slip quietly away into the night.

The annual conference is also taking shape. Two keynote speakers have recently been announced. Don Macke serves as the director of Practitioner Programs with the RUPRI Center for Rural Entrepreneurship in Lincoln, NE, partner and managing Director with HomeTown Competitiveness and Executive Director of the Community Assistance Initiative, an affiliated fund within the Nebraska Community Foundation. Don will kick off the annual conference. Dr. Vic Garcia, of the Children's Hospital, Cincinnati will close the conference. The annual conference will also feature pre-conference workshops, dynamic mobile learning workshops, and numerous opportunities to engage community development researchers and practitioners.

**Cleveland Could Become 100% Self Sufficient in Food Production**

A recent study by Ohio State University concludes that Cleveland residents could meet all their basic nutritional needs from [food raised within the city limits](#) while retaining \$29 million to \$115 million in the local economy. Reaching this goal would necessitate urban gardening plots on most vacant lots, growing food on some commercial rooftops, and helping homeowners grow food on their own property.

**Happiness and the City**

Happiness is only a possible [side benefit](#) to the true goal of cities, which is "...getting stuff done and, more importantly, generating the ideas that get stuff done."
